AGREEMENT

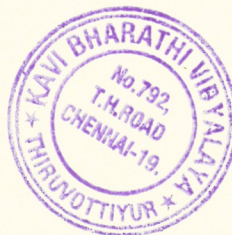
I, Secretary / Correspondent of Kavi Bharathi Vidyalaya, a unit of Mahamayee Ammal Thangappa Nadar Educational Trust, agree to abide by all the conditions stipulated by Government from time to time and hereby execute this undertaking as follows:

1. I shall create endowment for the amount prescribed by Government in the name of the school in the shape of Government securities like National Defence Certificates or National Plan Certificate or in fixed deposits in any Banking Company to which the Banking Regulation Act 1949 (Central X of 1949) applies. The Immovable property endowed in the name of the School shall not be sold, mortgaged, exchanged, gifted or alienated without the prior approval of the Government. The entire income derived from the endowed immovable property shall be brought to the general fund accounts of the school.

2. I shall provide the required lands for the schools and playground and as prescribed and produce documents in support of possession of such lands.
3. I undertake to provide the requisite building facilities for housing the school / classroom/library as prescribed by Government.
4. I shall equip library and laboratory as per the requirement stipulated by the Government.
5. I undertake to provide adequate and qualified teaching and non-teaching staff for the above institution.
6. I shall not appoint any teachers whose certificate has been suspended or cancelled or who has been declared unfit to be a teacher in recognized schools or who has been convicted for offence involving moral turpitude.
7. I undertake that in addition to the creation of the endowment the educational agency shall also deposit in any Banking Company which the Banking Regulation Act, 1949, (Central Act of X of 1949) applied in the name of the school a sum equivalent to a minimum of one month's salary of the staff employed in the school to serve as a working capital of that school.
8. I undertake not to collect capitation fee / donation from the students or their parents who seek admission.
9. I shall collect tuition fees and other fees from the students at rates as approved by our School Managing Committee.
10. I shall conform to the rules and regulation of Government and their instructions of the Director School Education / Director of Elementary Education issued from time to time.



11. I undertake that the Educational Agency shall fulfil all the conditions stipulated by the Competent authority at the time of permission to open the school or for starting additional standard or section.
12. I agree to function under the control of the Director of School Education/ Director of Elementary Education. The school may be inspected at any time by the Director of School Education/The Director of Elementary Education or by his nominee. Irregularities, if any, notice shall entail forfeiture of the permission granted to start the School and the Government shall have the right to take any action against the school as per the prevailing law in force.
13. I shall/shall not ask teaching grant from the Government for the purpose of disbursing their respective salaries.
14. The conditions agree to above are irrevocable.
